3) OBJECTS:

- (1) To Start or to take over Educational Institutions under the Management of the Gopi Krishna Educational Society, Proddatur and later to upgrade the Institution into a full Pledged centre and manage its affairs.
- (2) To rent or own buildings, grounds within its jurisdiction, to locate the institutions, Hostels, and staff quarters, and provide other incidental amenities.
- (3) To undertake construction of buildings for the institutions, Auditorium, Hostels, Staff Quarters, Toilets, Compound Walls, Walls and such others amenities.
- (4) To undertake the construction of rooms, halls, and Auditorium with fitting and other things according to the typed designed plan with the Donors name inscribed on the Donors donate in full the cost of the construction mentioned above.
- (5) To raise funds required for the fulfillment of the above objects by way of grants, subscriptions, donations, endowments, deposits and loans.

- 1) Name : SRI GOPI KRISHNA EDUCATIONAL SOCIETY,
- 2) Location : Amrutha Gardens,

 Proddatur - 516 360, Cuddapah Dist, A.P. INDIA.

The Society shall constitute of the following members. The members of the above society will be the local citizens of the Proddatur.

- 3) MANAGEMENT:-
 The member of the members of the Committee in seven. The Management of the affairs of the society shall vast in a committee consisting of eight members who are the local citizens elected by these members at a meeting convened for the purpose and shall hold office for a period of 3 years from the date of elections
- 4) OFFICE BEARERS
 The members of the committee shall elect from among themselves PRESIDENT, VICE PRESIDENT, SECRETARY and a TREASURER and three (3) members at a meeting held for the purpose. The term of the office bearers of the committee shall be conterminous with that of the committee
- 5) POWERS OF THE COMMITTEE AND OFFICE BEARERS:-
 The registration of the society shall render is a body corporate a by the name under which it is registered with a perpetual succession and a common seal. The society shall be entitled to require, hold and dispose of property to enter into contracts on its behalf, to institute and defend suits and other legal proceedings and to do all other things necessary for the purposes for which it is constituted.

6. The committee shall transact business of the society at their meeting held from time to time and shall make necessary subsidiary rules for a the improvement of the Institutions and for the determining the method of election of the association and for the fulfillment of the all other objects of the Association and subsidiary rules shall have the same force as the rules. They shall meet atleast once in 3 months of tenure. The President, cum Correspondent of the Society shall convene the meetings of the committee and shall issue notices with clear 10 days notice indication the time, date and place of mention and the agenda for the meeting. Any member of the committee who does not after receiving the notice, attend three consecutive meetings shall for fait his seat on the committee. The committee may, however, the reinstate him for adequate reasons then his application only twice during the term.
7. The President shall preside over the meeting for a committee and in his absence the Vice President shall preside in the absence of the both any member of the committee may be elected to reside over the meeting.
8. The quorum for the General Body meeting of the committee, there is 3/5th and Executive body is 2/3rd.
9. Any resolution passed by a majority of the members of the committee present is allied and binding. The President shall have a casting view in the case of the equal number of votes in either.
10. When there is a vacancy of vacancies on committee, the members of the committee shall fill up the vacancies by a co-option.
11. The President shall have general control and supervision over the Management and affairs of the Society.
12. The President-cum-Correspondent shall have the following powers, duties, and responsibilities subject to the resolutions passed by the committee
 - a) He shall be responsible for carrying out all the resolution that may be passed from time to time by the Committee and report to the Committee about the action taken at its next meeting.

- He shall appoint such employees who are necessary for the working of the Society with the approval of the Committee.
- He shall be the officer of the society the sue or the be sued on behalf of the Society all documents executed on behalf of or in favour of the Society what in his name.
- He shall maintain an upto date register of the all subscribers donors, life members and patrons.
- He shall have the power to acquire or alienate both movable and immovable properties of the society in such a manner as the committee deems fit in the interests of the society and on approval of the General Body of members.
- He shall every year prepare, the budget of income and expenditure of the enduring year, and place it before the General Body for consideration and approval, he shall also prepare in consultation with the Treasurer, a statement of receipts and charges and a Balance Sheet for the academic years ending with 31st May ever year and place them before the General Body, which shall be held every year on 25th June.
- He shall operate upon Bank accounts of the society but all negotiable instruments shall jointly be signed by the President-cum-Correspondent and the treasurer and also bear the seal of the Society.
- He shall issue printed receipts of the society bearing its seal for the all moneys received into the society.
- He may incur expenditure on the business of the Society and on the administration of the college according to the sanction made by the committee.
- He may keep an imprest cash not exceeding Rs.250/- within a meet incidental charges and unforeseen item of expenditure and same exceeding Rs.250/- should be deposited in a scheduled bank within 3 days.
- He may in this absence delegate any or all his powers to the Treasurer with the previous approval of the committee.
- He shall be incharge of all properties of the society except cash.

13. **THE TREASURER SHALL HAVE THE FOLLOWING DUTIES AND RESPONSIBILITIES.**
 - a) He shall be responsible for the safe custody of the funds of the society and shall keep regular accounts entrusted to him and produce them for audit or inspection together with vouchers and receipts.
 - b) He shall be custodian for the Bank Pass Books and cheque books, deposit receipts and other documents.
 - c) He shall not return any amount excess during Rs.250/- with his but remit it into the Bank.
14. **FUNDS:-**

The society shall act as Trust for funds and other properties of the society and to administer them according to the ruled framed in this behalf. The funds of the Society shall be spend only for the attainment of the objects of the society and no porting thereof shall be paid or transferred directly or indirectly to any of its members through and means:

The surplus funds of the society shall be invested in good working institutions such as Industrial concerns working on profitable basis as may be resolved upon by the committee.
15. **GENERAL BODY:-** The President-cum-Correspondent shall convene a meeting of the General body once in a year in accordance with resolution that may be passed by the committees fixing the date and agenda for the eligible to vote with in 15 clear days notice. The quorum for the General Body shall be 3/5th.
16. To amend or to alter or to cancel a rule enactment for a new rule shall be made except at general meeting or shall be deemed to have been passed unless 2/3rd of the members present vote for it.
17. A general meeting shall be called by the Committee within 30 days from the date of receipt of a requisition from three fifths of the members of the rolls.

In case the society has to be wound up the properties and funds of the society that will remain after full satisfaction of liabilities of the society will be transferred or paid to same other institution with similar aims and objects.
